

Cover picture – St Andrew's, Biggleswade

From February to June 2016, with significant financial and practical support from the Bedfordshire Association, the 1912 Gillett and Johnston ring of 8 bells at St Andrew's Biggleswade will undergo a major restoration with augmentation to 10 by John Taylor and Co of Loughborough. Retractable lifting beams have been fitted above the frame and an electrically operated sound management system, controllable from the ringing room, is being installed. The cast iron and steel bell frame has been altered to accommodate a ring of 10 bells on one level with extra 'H' frames cast to match the existing components. The frame has been thoroughly cleaned and will be repainted in goose grey while it is empty.

Some of the bells' partial tones have been slightly re-tuned to bring them into more correct alignment and they have all been cleaned by gentle sandblasting to remove generations of oil and dust. Two new trebles, given in memory of members of the congregation, were cast on 4th February to Gillett and Johnston profiles and lettered in the same style as the existing 8 bells. The 10 bells will be hung on new bearings with all fittings completely restored. New galvanised steel access and walkways will be installed in the belfry and the ringing room refurbished.

A new dumb bell for training purposes and a simulator will be installed to complete the project which will be set up as a ringing centre.

Association Rules

1. Name and Objects

The Association shall be called 'The Bedfordshire Association of Church Bell Ringers'. It shall have for its objects:

- The promotion of ringing for divine service.
- The cultivation of scientific change ringing.
- The preservation of proper belfry conduct.
- The encouragement of ringers to take part in the worshipping life of the church.
- To promote and support the care, maintenance, improvement and restoration of bells within the area of the Association.

There shall be three districts within the Association, namely the Bedford, Biggleswade and Luton Districts.

2. Membership

Register of Members

A register of members shall be kept. The contents and control of the register shall be responsibility of the General Committee. Personal information will be held in accordance with the Data Protection legislation. *Definition of Criteria for membership*

Ringing: Be able to ring rounds competently.

Residency. Either ring for Sunday Service at a tower within the Association boundary or reside within the Association boundary. The Association boundary is defined as those parishes which lie within the geographical county of Bedfordshire including the parish of Eaton Socon in Cambridgeshire.

Definition of membership categories

(a) Ringing Member (Resident)

A Ringing Member (Resident) must satisfy the criteria for ringing and residency.

A Ringing Member (Resident) may be elected at any public meeting of the Association or one of its Districts provided the proposer and seconder hold the status of Voting Member. A Ringing Member (Resident) may be elected prior to a peal attempt, provided the proposer and seconder hold the status of Voting Member and the election is ratified at a public meeting of the Association or one of its Districts within three months of the peal attempt.

- (b) Ringing Member (Resident, Life) This membership category is closed as from 18 May 2013.
- (c) Ringing Member (Non-Resident)

A Ringing Member (Resident) who no longer fulfils the criteria for residency may transfer to Ringing Member (Non-Resident) upon application to the Honorary Secretary. A Ringing Member (Non-Resident) who fulfils the criteria for Ringing Member (Resident) must automatically return to Ringing Member (Resident).

(d) Ringing Member (Non-Resident, Life)

A Ringing Member (Resident, Life) who no longer fulfils the criteria for residency will automatically transfer to Ringing Member (Non-Resident, Life). A Ringing Member (Non-Resident, Life) who fulfils the criteria for Ringing Member (Resident, Life) shall automatically return to Ringing Member (Resident, Life).

(e) Honorary Life Member

The Honorary Life Member category is reserved for any person who has given outstanding service to the Association. An Honorary Life Member may only be elected at an Association Annual General Meeting, provided that notice of such nomination shall be given in writing to the Honorary Secretary at least 14 days prior to the Annual General Meeting. The nomination must be proposed and seconded by members holding the status of Voting Member.

(f) Associate Member (Ringing)

An Associate Member (Ringing) must fulfil the criteria for ringing and must not fulfil the criteria for residency. An Associate Member (Ringing) may be elected at any public meeting of the Association or one of its Districts provided the proposer and seconder hold the status of Voting Member.

An Associate Member (Ringing) may also be elected prior to a peal attempt, provided that the proposer and seconder hold the status of Voting Member and they are taking part in the attempt. The election must be ratified at a public meeting of the Association or one of its Districts within three months of the peal attempt. (a) Associate Member (Non-Ringing)

An Associate Member (Non-Ringing) must not fulfil the criteria for ringing. The criterion for residency does not apply. An Associate Member (Non-Ringing) may be elected at any public meeting of the Association or one of its Districts, provided the proposer and seconder hold the status of Voting Member.

General

In order for a member to change between Ringing Member, Associate Member or Honorary Life Member an election must take place.

It is the responsibility of members to notify the appropriate Association officer of any alteration to their entry in the Register of Members.

3. Election and Voting

Only Ringing Members (Resident), Ringing Members (Resident, Life) and Honorary Life Members shall have power of voting on matters connected with the Association or one of its Districts. Such members shall be referred to as Voting Members.

A Voting Member is entitled to speak and vote at any public meeting of the Association or one of its Districts. Only Voting Members shall be eligible for election to any official position (as defined in Rule 4 and Rule 6). Voting will take place by show of hands or secret ballot as directed by the chairman of the meeting. Voting on the following Association matters shall be approved by an absolute majority: rule changes, finance, charitable status, election to Association office, membership and other items at the discretion of the chairman of the meeting (Association or District). All other proposals shall be approved by a working majority. An 'Absolute Majority' is defined as a majority of all Voting Members who are present and eligible to vote at a public meeting of the Association or one of its Districts.

A 'Working Majority' is defined as a majority of those Voting Members who are present, eligible and cast a vote at a public meeting of the Association or one of its Districts.

4. Management

The management of the Association shall be vested in a General Committee consisting of a President, a Vice-President, an Honorary Secretary, an Honorary Treasurer, an Honorary Librarian, an Honorary Peal Secretary, the Central Council Representatives, the three District Secretaries, two members of each District Committee and those Honorary Life Members elected. The President, Vice-President, Honorary Secretary, Honorary Treasurer, Honorary Librarian, Honorary Peal Secretary and Honorary Life Members shall be elected at the Annual General Meeting and serve for one year. The number of Central Council Representatives permitted by the Central Council shall be elected at the Annual General Meeting and serve for three years. The General Committee may appoint specialists, as required, to carry out certain roles, for example Technical Advisor, Safeguarding Co-ordinator and Web Master. In their roles, specialists will not be members of the General Committee. Any officer or Honorary Life Member shall be eligible for re-election. Each year the General Committee must appoint two of its members to be Bank Trustees. The General Committee shall have the power to co-opt if a position becomes vacant during the year. To form a quorum, there shall be a minimum of six General Committee members. A quorum must have at least one of the following officers: President, Vice President, Honorary Secretary and Honorary Treasurer.

5. Roles and Responsibilities

The Honorary Secretary shall be responsible for recording the activities of the Association as a whole, the preparation of the Annual Report and membership records. The Honorary Treasurer shall be responsible for the recording of finances of the Association. The Honorary Peal Secretary shall record details of all peals rung by the Association and shall ensure that the rules of the Association and of the Central Council have been observed. The Technical Adviser shall assist and advise in all matters concerning bells and their fittings at churches within the Association boundary. The Safeguarding Co-ordinator shall be the focal point for all complaints, shall take the complaint seriously and pass it on in accordance with Diocesan guidelines. The Central Council Representatives shall attend meetings of the Council on instructions of the General Committee and represent the declared views of the Association.

6. Districts

Each District shall elect a District Committee, consisting of a Chairman, a Secretary, a Treasurer and at least four other members, with other officers as they may find necessary. Each Treasurer shall collect the subscriptions of members and other monies payable to the Association's funds. Each District shall report annually on its activities and membership.

7. Subscription

The subscription of each member (who is liable to pay an annual subscription) shall be due on January 1st and shall be paid before the Association Annual General Meeting in each year. Membership shall cease as from 1st January, if the subscription is not paid within the specified time period. The appropriate subscription for a new member shall be payable upon election.

The subscription level for each membership category and its effective date (as defined below) shall be recommended by the General Committee and approved at an Association Annual General Meeting. If the Association Annual General Meeting rejects the recommended subscription levels, the existing subscription levels will then remain in force until such time as the General Committee make further recommendations which are accepted by the Annual General Meeting.

Definition of Subscription Levels for Each Membership Category

(a) Ringing Member (Resident)

There shall be three classes of Ringing Member (Resident):- Under 19, 19 to 64 and 65 and over. The age requirement shall be determined by the age of the member at the 1st January in each year. Each member shall pay an annual subscription.

(b) Ringing Member (Resident, Life)

This membership category is closed as from 18 May 2013.

(c) Ringing Member (Non-Resident)

A Ringing Member (Resident) who has paid five or more consecutive annual subscriptions may transfer to Ringing Member (Non-Resident) without further payment; otherwise the transfer may be made by payment of a single fee. Such transfers shall be deemed to begin on 1st January after the date of transfer.

(d) Ringing Member (Non-Resident, Life)

Such transfers shall be deemed to begin on 1st January after the date of transfer. No payment is required.

(e) Honorary Life Member

Exempt from subscription payments.

(f) Associate Member (Ringing)

Each member shall pay a single payment upon election.

(g) Associate Member (Non-Ringing)

Each member shall pay an annual payment.

A table giving subscription rates for each membership category shall be published in the Annual Report.

8. Peals

All peals rung by the Association shall be recorded in the Annual Report, provided that all those taking part are Ringing Members, Honorary Life Members or Associate Members (Ringing). Full details of the peal including the composition, together with the peal fee shall be given to the Honorary Peal Secretary by the conductor within four weeks or not later than the 14th January in the following year, whichever date is earlier. It is the responsibility of the conductor to ensure compliance with these rules. The peal fee and its effective date shall be set by the General Committee and published in the Annual Report.

9. Annual Report

A report shall be published annually before the Association Annual General Meeting, containing a list of officers, the Association rules, the Committee's reports, statements of accounts, peals rung during the year, other announcements as the General Committee shall find necessary and a list of members. The list of members shall be compiled as follows:

- a) Honorary Life Members, Ringing Members (Resident), Ringing Members (Resident, Life) and Associate Members (Non-Ringing) annually;
- b) Ringing Members (Non-Resident) and Ringing Members (Non-Resident, Life) in the year of transfer:
- c) Associate Members (Ringing) in the year of election.

Each member listed in the Annual Report shall be entitled to a copy of the Annual Report; others may purchase copies if available. The fee shall be set by the General Committee and published in the Annual Report.

10. Meetings

The time and date of the Association Annual General Meeting together with the District in which it is to be held shall be fixed by the previous Association Annual General Meeting. The General Committee shall have power to arrange other meetings of the Association when required. Each District shall hold an Annual District Meeting in January and monthly meetings when possible.

11. Accounts

The General Committee must:

- Authorise opening and closing all Association bank accounts, and
- Review all bank accounts regularly to make sure that charges and/or interest rates are competitive.

The Honorary Treasurer and Bank Trustees must be signatories and any two of these three must authorise payments and/or withdrawals

An Independent Examiner shall be appointed at the Association Annual General Meeting to examine the accounts of the Association at the end of each financial year.

12. Rule Alteration

All alterations or additions to the Rules shall be made at the Association Annual General Meeting and notice of any alterations or additions shall be given in writing to the Honorary Secretary in full, at least 14 days previous to such a meeting.

13. Affiliation

The Association shall be affiliated to the Central Council and shall abide by the Rules and Decisions thereof.

14. Interpretation of Rules

The interpretation of these Rules, and matters not covered by them, shall be finally decided by the General Committee.

15. Dissolution of the Association

If the Trustees decide that it is necessary, or advisable, to dissolve the Association, they must present a

resolution to a General Meeting called for this purpose. The resolution must be agreed by at least a twothirds majority of those present and voting. The resolution may give instructions for the disposal of any assets remaining after satisfying any outstanding debts and liabilities.

The assets must not be distributed to Association members; they shall be given, or transferred to, a charitable institution(s) that have objects similar to all, or some, of the Association's objects, as the Association may agree. If this is not possible, the assets may be given or transferred to some other charitable purpose.

The Ronald J Sharp Bell Fund Code of Practice

- 1. The fund shall be known as the Ronald J Sharp Bell Fund.
- 2. Objectives. The objective of the fund shall be to advance the Christian Religion by:
 - (a) Providing financial assistance in the form of loans to churches within the territory covered by the Bedfordshire Association of Church Bell Ringers for the following purposes:-
 - (i) Augmentation, recasting, or any other work on bells, frames and fittings
 - (ii) Major work in ringing rooms, e.g. floors
 - (iii) Work to the fabric of towers, e.g. sound control
 - (iv) Provision of and hanging of new peals.
 - (b) Providing grants to the Association General Committee and the District Committees for the following educational purposes:-
 - (i) Training courses on bell ringing
 - (ii) Educational materials relating to bells and bell ringing
 - (iii) Promotion of bell ringing.
 - 3. Administration. The administrators of the fund shall be known as the 'Fund Committee'. The Fund Committee shall comprise one member from each of the three Districts of the Association, together with the President and the Honorary Secretary of the Association. The Fund Committee shall be empowered to co-opt from the Districts to fill vacancies as necessary. The Fund Committee shall be empowered to approve or reject applications for loans and grants. Applications for loans and grants shall be made in writing to the Honorary Secretary. Having received an application for a loan or grant, the Honorary Secretary shall call a meeting of the Fund Committee within twenty one days. The Honorary Treasurer and the Trustees of the Association shall be the trustees of the fund, any two of whom shall be cheque signatories.
 - 4. Income and Investment. The responsibility for fund raising and investment shall be that of the General Committee of the Association. The General Committee of the Association shall have the power to borrow money for the purposes of the Fund.
 - 5. Applications. Applications for a loan shall include all relevant details as follows: An estimate of the proposed work, a specification of the proposed work and details of the financing scheme. Duration of the loan shall be twelve months. An extension of the loan may be applied for. Interest rates on loans shall be decided by the General Committee. A 'Form of Agreement' shall accompany all loans. No loan shall be for less than £250 or such a sum as shall be decided by the General Committee. Applications for a grant shall include a brief description of the proposal, estimated expenditure and financing available. A grant shall only be paid to defray actual expenses and proof of expenditure must be supplied.
 - 6. Reports and accounts. The General Treasurer shall prepare accounts for the fund each year ending 31st December. The accounts shall be included within the body of the Association accounts. A report of the activities of the fund shall be presented to the Association AGM by the Fund Committee.
 - 7. Dissolution. In the event of the dissolution of the fund the accrued assets of the fund shall be paid into the General Fund of the Association.
 - 8. Provision for changes to the code of practice. No amendment of; addition to; or deletion from this code of practice shall be made which would cause the Association to cease to be a charity at law. Propositions for changes shall be made at the Association's AGM.

Decisions of the General Committee

20th May 2000: Rule 5. The interest rate for loans is nil for the first twelve months. Should the loan period be extended, interest will be charged at the rate that would have applied had the loan not been made.

Association Officer Reports

President's Report

2015 was another busy year for the Association. It started with the usual round of Annual District Meetings, soon followed by the General Committee Meeting. Each District has held full programmes, including monthly meetings, outings, training sessions, quarter-peal days and various social events. The Association AGM was held in May hosted by the Luton District at Leighton Buzzard.

On the 6 June the Association competed in the Ridgman Trophy contest at Wisbech. This is a 10 bell striking competition for Eastern Region Associations and the test piece was a half course of Cambridge Royal. For several of the team it was their first competition on 10 bells and it was good to see two of our Ringing World National Youth Competition team taking part. The draw takes place in advance of the competition and we were drawn last out of eight teams, this did give the band the opportunity of fitting in a morning practice at Kettering on the way to Wisbech. The extra practice obviously helped as we came third, only 2% behind the Suffolk Guild and some distance ahead of the fourth placed team. Thanks go to Linda Garton for making the arrangements.

2015 was also another very successful year for our young ringers as was witnessed on the 11 July in Oxford at the Ringing World National Youth Contest, when those representing the Association retained The Whitechapel Trophy for the third year running. The Bedfordshire Team were, Alice and Clarrie Scott, (Biggleswade), Melissa Nash (St Andrew's Bedford), Sammi Brett (Linslade), Lizzie Pawley (Luton District), Cameron White-Spunner (Houghton Regis), Dean De-Matteis (Husborne Crawley) and Thomas Monks (Eaton Bray) and were under the expert guidance of Linda Garton and Lyndsey Brett. It was a fantastic 'team' effort and I am still not sure if it was the participants or the supporters who were more excited when the result was announced. Another wonderful effort! We also had two travelling reserves, Jonathan Nash (St Andrews Bedford) and Becca Smith (Linslade) and they were able to take part in all the activities laid on for the competitors. We will be entering a team in the 2016 competition in London on 2 July, when, as defending champions we will be hoping to win the trophy for a fourth successive year.

Alice and Cameron have rung in all five of the competitions so far and 2015 was to be Alice's last as she has now exceeded the age limit. As Alice has rung the treble in all of the contests we now need to find another expert treble ringer! I cannot praise our young ringers highly enough for their efforts and commitment to the Association. We continue to run a monthly 'get together' on the 4th Sunday afternoon which is regularly attended by 15 to 20 young ringers and the sessions are structured for them. This has given them all the opportunity of meeting ringers of a similar age across the Association. I would also like thank all the ringers and parents

who give up their Sunday afternoon to transport these youngsters to the relevant tower and to Linda Garton and Lyndsey Brett for running them.

The Association Striking Contests took place in September hosted by the Biggleswade District on the back six at Clifton. This year all three Districts plus a scratch team entered the Young Ringers Competition for the Melville Cup. The Biggleswade District did have to enlist the help of a couple of ringers from the Bedford District to make up their team, the important point being that all young ringers who came along on the day were able to take part in the Competition. The cup was won by Bedford Band with an excellent exhibition of rounds ringing. The St Peter's Cup was a very closely fought contest with the winners being Kempston.

Congratulations go to both of these teams and thanks go to the Clifton and Campton ringers for the excellent tea.

In October an outing was arranged for the Young Ringers to Cambridge to ring at five towers including the 12 at Great St Mary and the heavy 8 at the Catholic Church. 13 young ringers came along with about the same number of helpers so there were some crowded ringing rooms! Thanks go to John Loveless for suggesting and arranging the outing.

As you will have been aware there was a Central Council initiative to encourage 300 ringers to ring their 1st first peal during 2015. I am delighted to report that fifteen of our members achieved this goal during the year. More on this is covered elsewhere in the report. Congratulations to all.

Finally, I would like to thank everyone who has suggested, arranged, assisted and supported Association events and activities this year, and I look forward to 2016 being an equally active and successful year.

Treasurer's Report

This year we are showing a small surplus of £153.62. Peal fee income increased by £10 and gift aid by £40. We also received generous donations of £140, this being the surplus from the AGM teas and the striking competition teas. We were able to transfer £2125.81 into the Association BRF which now stands at £8442.92.

Technical Advisor's Report

One visit was carried out this year.

Great Barford

I was asked by the incumbent to inspect the bells after a slider was broken on one of the bells.

The western tower contains a ring of five bells cast by Hugh Watts II in 1636/7 which are rung from the ground floor. The bells are hung in a massive low-side wooden frame which was strengthened when the bells were re-hung by John Taylor & Sons in 1905. The bells are hung on cast-iron box section headstocks which are in a rusty condition fitted with castle top plain bearings. All the bells are fitted with independent crown stapled clappers the bushes of which are all worn. The bells have been liberally greased over the years a quantity of which has run down onto the frame. I suggested that all frame bolts, wheel bolts, bell bolts, etc. be checked for tightness; all grease be cleaned off the frame; lift the bells and clean the plain bearings and housings to remove all grease and dirt and then lubricate with a suitable oil. I also suggested that the cast-iron headstocks be wire brushed and then painted with good quality paint. I also suggested that all the clappers be re-bushed.

For the future I suggested that the bells should be inspected by a reputable bell founder/bell hanger.

Ronald J Sharp Bell Fund Committee Report

_

This year's Committee were Andrew Dennison (Bedford District), Linda Garton (Biggleswade District), Sally Creveul (Luton District), Sue Silver and Teresa Brown. We awarded one new grant:

Biggleswade District (on behalf of the Association) – tower donation costs for Bedfordshire Young Ringers monthly, structured training sessions: a grant of up to £120 to provide 12 x £10 tower donations.

Updates on previously awarded grants:

- **1. Bedford District, River Festival July 2014:** a £315 grant to cover River Festival pitch costs was awarded in 2014. As reported last year, Bedford Borough Council agreed to reduce this cost to £165 and the account wasn't settled until this year.
- 2. St Peter and St Paul, Cranfield: a grant of £765 (maximum) was awarded in 2014 towards the cost of providing simulator equipment for training purposes. However, the company selected by the Cranfield ringers were revising their specifications and the equipment wasn't available to buy in 2015. It is hoped

that this can be progressed in 2016.

3. St Andrews Biggleswade: In 2014 a grant of £9000 was awarded towards the cost of a sound management system to enable the tower to be used as a recognised Central Council Ringing Centre and available for use by the whole Association. One of the stipulations of the award was that the grant be taken up by 31 December 2015. Over the course of the year it was apparent that, because a significant delay in obtaining the faculty, this wouldn't be achievable.

The delays were due to additional reports being required by the Diocesan Bell Advisor, unforeseen work on the ringing chamber ceiling and tower clock and the faculty application being lost in the 'Diocesan system'. The faculty wasn't formally granted until 16 October which meant that it was impossible to meet the original work scheme proposed by Taylor's Bell Foundry.

As a result, the Committee unanimously agreed to extend the deadline for the grant to be taken up to 1 June 2016. New bells were due to be cast on 4 February 2016 and tower work begun the week after. Taylor's and the ringers are confident that the project will be completed by this date.

The 2014 RJ Sharp Committee's report generated a discussion at the February General Committee meeting. The legality of one of our decisions was queried - had we had acted within the RJ Sharp Code of Practice? After considerable discussion a vote that we had acted legitimately was taken and passed by a majority.

Review of the RJ Sharp Fund

The General Committee also asked us in February to reconsider our 2014 review recommendation not to change the Code of Practice or the Fund's scope to only provide 'training and education' grants.

The RJ Sharp Committee agreed to recommend that:

- as the R J Sharp Fund is distinct from the Association Bell Restoration Fund, with no conflict or overlap between the two, there is still no need to make any changes to the current Code of Practice or make it a 'training and education' only Fund; and
- The General Committee should consider a 'reserves policy' for this Fund.

2015 was the second full operational year for the Association Bell Restoration Fund (BRF). This year the Fund has increased by £2125.81 from £6317.11 to £ 8442.92. This level of income is likely to become the more usual expected amount, with no transfer of surplus from Association's General Fund this year.

Despite a few enquiries, no applications for grant were received this year. Information about the BRF is on page 17 and on the website and I encourage applications from church authorities for bell projects that are within the scope of the Fund.

This year's District representatives were Andrew Dennison (Bedford District), John Loveless (Biggleswade District) and Simon Stranks (Luton District).

Thanks to those who made personal donations and to all members who supported the BRF by paying a subscription this year.

How to Retain the Whitechapel Trophy - observations from the sidelines. (This article was published in the Ringing World)

The team - the key element to retaining the RWNYC trophy was of course the band. Six of the winning band from last year rang again this year with the other two being the reserves from last year. From six different 6 and 8 bell towers, including at least one from each of Bedfordshire Association's three Districts, the young ringers are all aged 13 or over. All of them are competent quarter peal ringers who have been ringing for at least 2 years, several ringing their first peals recently.

Many are the children of ringers and have been at least part-taught by their parents. This seems to have some distinct advantages. Amongst others: the parents understand what is happening and can help explain some aspects, they are more likely to give their time to transport to events and ringing parents can give easier to access to some of the ringing away from home towers like District meetings. Of course we also have some other tower captains and teachers who give up their time to facilitate our junior ringers attending activities.

The activities - there is a monthly practice at which any young ringer from an Association tower is welcome. This is usually attended by in excess of 15 young ringers from 8 towers or more. This may involve 45 minute drives each way for the parents but the young ringers are keen. These practices have been running for about three years and the half-time break for refreshments has evolved to permit the 'taxi drivers' to drink tea almost throughout the two hour session which has gone down well. Initially there were more 'training' exercises but bell control is not an issue any more and most ringing now is things purists would recognise. Whilst two adults run the sessions many others are often around in an open and friendly atmosphere, including more than one thousand pealer ready with advice if asked. Some of the young ringers get opportunities to ring things they do not at their home towers, others the chance to reinforce what they are currently working on. Also within the Association - there are various monthly practices across the Association including Surprise Major and 10 bell, which are attended by some of the young ringers. The young ringers are always made welcome at these with even some of the more vocal local conductors perhaps softening and finding far more to critique amongst the adults present, although this could just be the reality of the ringing. Recently a 12 bell practice has been trialled to open a further door for the young ringers who might wish to walk through.

Melville Cup - once a year, in September, the young ringers become rivals as they compete representing their Districts in the Melville Cup, a rounds striking contest started in 2008 and won at least once by each District. Most years each District musters a team giving many a gentle introductory contest experience. It is held prior to the Association striking competition which is for the two method ringing towers from each District that have qualified from the District contests. Last year the winning young ringers rounds piece was judged as good as the winning method piece.

For the RWNYC - there was one practice for the contest, the Sunday before on a similar weight 8, which all but one of the band were able to make. This concentrated on the test piece with reserves swapping in and out 'just in case'. Here there was concentration on the striking more so than other times. At other times expectations vary for different ringers, now all were asked for minimum mistakes which they seem happy to seek.

Too much emphasis? In the scheme of things, the activities for younger ringers are a relatively small part of the Association's activities. They are

perhaps the most vibrant, but that is down to the enthusiasm of the participants (which may well then feedback into a willingness amongst organisers to plan the odd outing etc.). If the other activities are stale that may be because newer faces are fewer and formulas familiar. On average, young ringers seem more willing to ring beyond their home towers or maybe they are more easily persuaded/supported by their teachers/tower captains. **Team Effort -** I have deliberately not named individuals in this piece because the whole thing is really a team effort with many roles being played by a host of individuals. This has the positives of everything not being too dependent on one or two individuals and no one individual having to do too much. We are lucky to have some highly skilled ringers and experienced ringing teachers to help guide our enthusiastic young ringers. There seems to be enjoyment on all sides which must bode well for things to continue onwards.

Ridgman Trophy Ten Bell Striking Competition – 6 June, Wisbech

'The Ridgman' is an annual 10 bell contest established in 1988 to mark Bill Ridgman's 28 years as president of the Cambridge University Guild from 1961 to 1989. Sadly Bill died in 2011 but his son Tom maintains an active involvement in the event.

The aim back in 1988 was to establish a competition to be hosted in turn by all the participating guilds and associations, these to be the CUG, the Ely DA and all the surrounding guilds and associations. The test piece tends to alternate between Stedman Caters and Cambridge Royal, 200 changes. The Bedfordshire Association has been an active participant over this time. With a strong focus on selecting strong bands that are well prepared we have won the competition 6 times in the last 10 years.

The focus changed a little this year. With a new organiser, Linda Garton, in place we moved to a brand of organisation where things were finalised a little closer (or very much closer) to the event and some new, younger ringers also came into the band. Sammi Brett and Lizzie Pawley have twice been in the winning Bedfordshire team in the RWNYC 8 bell competition for under 19s, so are not new to winning competitions, but this is supposedly a more grown up event (arguably, perhaps), generating perhaps a little more expectation, although superseding 2014's performance was unlikely to be difficult! We also welcomed Nick and Lyndsey Brett and Jonathan Pawley, so a real family feel to the day.

From the outset I was thinking that a solid performance as well as a really good day out was on the cards, and I had no concerns as I knew that our newcomers were used to ringing on 10. We then put ourselves in an ever stronger situation though another 'last minute Linda' innovation, literally 3 days before the Saturday of the contest. Linda decided on a practice en route to Wisbech so we had an hour's practice ringing at Kettering in the morning, with the focus very much on replicating competition conditions,

defined practice routines and finally ringing a decent full half course of Cambridge Royal. Good, lots of improvement in the hour and the obligatory lecturette from me on the importance of avoiding mistakes!

We were drawn to ring at 4.00pm preceded by photos so what had been a pretty relaxing day was reaching the business end. In the 1990's the oldstyle ring of 10 at Wisbech (all cast by William Dobson in 1823) was re-tuned with the bells rehung in a new frame with new fittings. Every time ring here I am amazed by the quality and richness of the bells. They are mellow, prominent inside yet well balanced, as well as being crystal clear in the ringing chamber. When you pull off here you wonder how bells cast in 1823 can be so good. There is a sting in the tail however because they are quite odd struck and need pulling! Overall verdict is a top class ring but no place for an easy ride.

The verdict on how the teams performed was given by David House, who is acknowledged as being an excellent judge, not just of claret but of ringing as well. Most of the ringing produced by the eight teams competing had been slow (our band included) due mainly to the clarity of the bells which means that bands 'over ring' them. But after we finished our test piece I remember thinking we had performed well and would hopefully be in the top half. It was pleasing that we kept improving not just during the test piece but consistently during the day. David placed us third with 76%, well clear of Essex with 65%. Ely DA were first with 85%, with Suffolk on 78%, so we were very close to coming second and I pondered (privately) on the value of no mistakes! So all in all a really worthwhile day which we all enjoyed. I sometimes observe that ringing can transcend most boundaries. This was demonstrated not just by the teamwork that drove our ringing at Kettering and Wisbech but also by the wider fellowship ringing offers, for example all of our band plus supporters spending a very pleasant hour or so in the local Wetherspoons before setting off for home. Next year it would be great to resume the winning but most of all I'd like to see more of our young ringers pushing for inclusion in the team and finally the team achieving no mistakes – of course! **John Loveless**

First Peal 2015

2015 was the 300th anniversary of the first-ever peal, rung at St Peter Mancroft, Norwich, on May 2 1715. When the Central Council launched 'First Peal 2015' with its target of 300 first pealers in 2015 I have to confess that I was expecting a damp squib. After all, first pealer numbers had been falling steadily for some years – from relative peaks of around 250 per year in the early 2000's the annual number had dropped to not much over 150, with a dip to 139 in 2014.

Regular reporting throughout 2015 showed that although first pealers were coming through at a reasonable rate we were still consistently below target. The May 2, 300th anniversary, bank holiday weekend saw 18 first pealers, a pleasing 'peak'.

The 2015 total was 387, 29% over target, a fantastic achievement. There was a clear gathering of momentum during the final quarter which saw 177 first pealers, with 75 in December alone. Full details, available on PealBase (http://www.pealbase.ismysite.co.uk/pealbase/firsts.php?y=2015) tell the story. My reading is that the announcement of First Peal 2015 stimulated significant interest, with many people very keen to achieve their own first peal who might otherwise have not thought about it as a realistic possibility. These people, stimulated by their teachers and mentors, worked hard during

the year to achieve the required standard and this probably accounts for the phenomenal final quarter.

So what about here in Bedfordshire? Well, we certainly did our bit. We were not particularly explosive off the blocks but 15 Bedfordshire ringers rang their first peal during 2015, and about half of these were teenagers. 7 were rung in November/December so a cracking finish to the year. We know that a lot of effort went into these achievements and those 15 people richly deserved their reward. It is also very important to acknowledge the support they receive from other ringers without which none of this happens. The regular Bedfordshire Young Ringers practices, 'Not So Young Ringers' events and activity in the various districts are the bedrock of this. 'One-offs' such as the Firsts Day, organised for the anniversary day May 2, are designed to help ringers progress but, as important, also get enthused. There are plenty of both in Bedfordshire at the moment - long may it continue.

Here's a target for next year – each of the 15 to ring in a peal for a first pealer during 2016!

The James W Yates Raise and Lower in Peal Challenge Trophy

By popular demand we include information about the challenge competition for 'Jim's Jug' in the annual report again.

In 1977 James W Yates, an Ampthill ringer at the time, gave the Association a large pottery jug as the trophy for a 'Raising and Lowering in Peal' challenge competition. The trophy was made at the Wenfordbridge Pottery in Cornwall and is known as 'Jim's Jug'; it is a splendid three handled jug with a 7 pint capacity!

Jim's challenge was to encourage bands to raise and lower six or eight bells in peal and be judged for good striking throughout.

The current holders are Biggleswade. They successfully defended two challenges from the Goldington band in 2010 and 2011.

The full challenge rules are on the website but, in summary, Biggleswade remain trophy holders until another band (or two), of resident members who are also Sunday service ringers, challenge them to a contest to raise, stand and lower 6 or 8 bells in peal. Defenders and challengers between them:

- agree on a venue for the contest and are their own umpires.
- appoint a judge who will judge teams solely on their striking; the team with the least faults and best overall performance being the winner.

The contest must be held no later than 4 months after the challenge has been accepted. The holders are bound to accept a challenge or, if unable to do so, must concede to allow a contest between other challengers to a maximum of three teams per contest.

There must be least 4 months after a contest before a challenge can be made so another challenge is long overdue! The Biggleswade band looks forward to defending a challenge soon.







Obituaries

Ronald E J Freeman (1933 - 2015)

Ron Freeman, a former ringer at Kempston and Wootton, died on 11 March 2015 aged 81 years.

Ron was born and brought up at Box End, Kempston and as a teenager he learned to ring the bells at All Saints Church, Kempston where his father, Ernest Freeman, was a ringer. He was a member of the Bedfordshire Association of Church Bell Ringers from 1948 to 1959 and from 1976 to 1979, and he rang three peals for the Bedfordshire Association - in 1949 (at



Kempston), 1950 (at Stagsden), and 1953 (at Kempston for the Coronation of Queen Elizabeth II).

Ron served his apprenticeship as a pattern maker at W H Allen in Bedford and he subsequently worked as a pattern maker at Hobkirk's foundry in Kempston. When the Kempston bells were rehung in a new frame, Ron was a member of the Kempston Parish Church Bells Appeal Committee from 1976 to 1979. He played a valuable part in the rehanging scheme, including making the pattern for the 15 frame castings and (together with the late Jim Routledge) arranging for the castings to be machined and drilled, thus resulting in a considerable financial saving.

Ron is survived by his wife, Dorothy, who he married at Wootton Church in 1966. His funeral service took place at Norse Road Crematorium, Bedford on 26 March 2015.

W Ralph West (1921 - 2015)

Ralph West passed away peacefully at home on 8 March 2015 aged 93 years. He was a member of the Bedfordshire Association of Church Bell Ringers from 1976 to 2011 and Tower Captain at Biddenham for many years. He rang one peal (a peal of Grandsire Triples on 14th June 1987 which was the first peal on the eight bells at Biddenham following their augmentation from six to eight bells). A memorial service celebrating Ralph's life took place at Christ



Church, Denmark Street, Bedford, the church where Ralph worshipped, on 13 April 2015 and his ashes were interred in Biddenham Churchyard on 18 April 2015; a quarter peal of Grandsire Triples was rung on the bells at Biddenham during the interment.

Ralph was a founder member of the Biddenham Handbell Ringers with friend and neighbour Anthea Slark who wrote the following obituary which is

reproduced here with permission from Anthea and the editors of The Loop (formerly Biddenham Bulletin).

Richard Hillson

We are sad to report the death of Ralph West on 8th March 2015. Ralph was one of the oldest residents in Biddenham and lived in the village all his life. He was born at 45 Main Road and attended the (old) village school remembering the very fierce Rev (Billy) Norman who visited once a month. Afterwards he attended the Modern School and left in 1938 to join GPO telephones on a 2 year apprenticeship. In 1943 he was called up but spent most of the war at Catterick Camp where he taught communications to new recruits. Back in Bedford he continued his career as a telephone engineer progressing through the organisation to become Head of Customer Installation UK until his retirement in 1983. Also in 1943 he married Megan and bought the plot of land at 13 Church End, eventually having a house built in which he lived until his more recent move to Day's Lane. Megan died in 1998 following many years with disabling arthritis. Ralph cared for her faithfully throughout often inventing equipment to make her life easier. Ralph has a son, Nick, 3 grandchildren and 3 great grandchildren.

Music was Ralph's greatest interest; he has always played the violin, leading the Bedford Symphony Orchestra at one time. His father and grandfather were tower bell ringers (at Biddenham), although he did not start until he was in his 50s and later became Tower Captain. Together with Anthea Slark he set up the Biddenham Handbell Ringers in 1991 and was both Chairman and Musical Director for many years.

After Megan's death, Ralph was able to indulge his passion for travel and visited all 5 continents, often on cruises. During travels in America he met Sue and following a long distance romance and many obstacles in the form of British Immigration officialdom they were eventually married in July 2013. Sue has cared for Ralph wonderfully during his final years and they shared a strong Christian faith. The church was very important to him, both St James's, Biddenham and Christ Church, Denmark Street, and he hosted a weekly bible study meeting at his house. In spite of age and infirmity Ralph remained mentally active until the end always interested in everything, a good conversationalist with no apparent memory loss. He described himself as a 'gadgets guy' and kept up to date with the latest electronic equipment. Anthea Slark interviewed him for the Biddenham Bulletin magazine in 2011. When asked what piece of advice he would like to pass on he replied – 'read your bible – it's full of good advice on how to lead your life' (Ralph read through the whole bible every year). In answer to the guestion – how would vou like to be remembered, he said "He lived a Christian life to the full". What better epitaph for Ralph. We extend our sympathy to his wife Sue, his son Nick, and the rest of his family.

Anthea Slark

David Mervyn John Pegg (1947 - 2015)

Dave was born in 1947 the youngest of 10 children. By the time he was 3 years old both his parents had died, resulting with him living with a succession of siblings eventually being based in Biggleswade where he went to school. He lived in the area for the rest of his life and did an apprenticeship in carpentry, which came in handy later on making and fitting bell stays! The following is an extract from the eulogy given at Dave's funeral:



"He first came into contact with the Northill bell ringers in the Crown at Northill on Monday nights about 8 years ago, where we enjoy a post practice ale or two; he particularly enjoyed helping himself to the complimentary 'bellringers chips'! We only stood for this behaviour for so long - eventually, about 3 years ago, he had to have a go, and, to most people's amazement, not least his own, he turned out to be pretty good. He was a very useful, regular Sunday ringer, ringing rounds and call changes and could plain hunt. He was elected as a member of the Bedfordshire Association of Church Bellringers, he took part in striking competitions and enjoyed the social camaraderie, as well as the ringing. Bell ringing suited Dave's love for tradition, rural values and friendship and we miss him dearly". Dave died in Bedford Hospital following a stroke earlier in October. **Sue Melvin**

Frances Spavins (1917 - 2015)

Francis Spavins, nee Parkinson, (always known to ringers and friends as Fran) died on 26
December, aged 98. She was born in Raunds
Northamptonshire on 10 Feb 1917, the youngest but one of seven children. She went to school, firstly at Stanwick, and later moved to Rushden where after leaving school at the age of 14, she became a shoe hand. Fran met Kenneth Spavins, who was living and working in Risely, at the age of 18, probably at a social in Rushden, where Ken had cousins. Born at the end of World War I and then experiencing the beginning of World War II, they planned to wait until the war ended before getting married, but with that seeming unlikely, they married on 2 January 1943 at St



Peter's Rushden. Their first home was a farm cottage on the outskirts of Risely where Ken worked as a farm labourer, moving after about three years into the village and a house opposite the village hall. Fran was active in the

WI and amateur dramatic group, both on stage and at the piano. She did some part time jobs, mostly creative, such as designing and stitching smocking patterns for a children's clothing manufacturer in Bedford. She also took the Sunday school and participated in all aspects of village life. In 1955, following a change in jobs, the family moved to Woburn where they soon established themselves in the life of the village and church, Fran, along with Ken and their daughter Anne sang in the village choir, and also in the choral group conducted by the then Vicar (Rev Tom Gunner). Ken took over from Doug Harris as Tower Captain and taught Fran and Anne to ring on the clock bell (former 7th) at Woburn old church. Together they visited and rang at many churches across the country, and following Ken's election to the Ancient Society of College Youths, Anne recalls visiting St Pauls Cathedral and Westminster Abbey. Ken, supported by Fran, also led the Woburn handbell ringers, a tune ringing group mainly comprising children from the village, who were always very popular at the Church fete and various hospitals and care homes at Christmas time. For several years they were invited to play for the Duke and Duchess at Woburn Abbey. Fran later continued the handbell ringing tradition with the village Girl Guides. Fran served on the PCC for many years, and following Ken's death in 1982, she took his place as Churchwarden, later being elected Churchwarden Emeritus in honour of her faithful service. In addition to flower arranging. church cleaning, welcoming visitors, and many other activities, Fran was principally responsible for the embroidering of two magnificent alter cloths for Woburn Church. Sadly a fall suffered while in her 80s curtailed Fran's church attendance and connections with ringing, but she remained active until almost the end of her life, making the palm crosses for the most recent Palm Sunday services.

Fran was elected to the Bedfordshire Association in 1955 and remained a member until 2002. My personal memories will be of a reassuring and kindly lady who was always very welcoming and helpful to visiting ringers. When asked about access to the tower her usual reply was "oh, don't worry, I shall be there" and sure enough she always was. On occasions I would return the key to her home at 44 George Street, but it was seldom necessary as she was often still in church at the end of the ringing. Without people such as Fran, ringing as we know it would be so much the poorer. May she rest in peace.

Pat Woolhead (1948 - 2015)

Pat was born in Aspley Guise in 1948. She met Martin, who lived in Eversholt, when she was fifteen and they eventually married and had two daughters, Samantha and Nadine.

When Nadine was fourteen she started ringing at Aspley Guise and was one of the team until she married and moved away. Pat then decided to fill the gap in the band and learn to ring. She was a regular and very dependable member of the local band. She was also a member of the local PCC, WI and British Legion.



In 2007 she was diagnosed with cancer and was treated at Leicester, during which time she still came ringing whenever possible and was declared clear. Alas the cancer returned in 2013 and although she had two more courses of chemotherapy, during which time she came ringing whenever she was able. She suffered a fatal heart attack in January 2015. A very much missed friend whose place will be very hard to fill. May she rest in peace.

General Information for members

Safeguarding children and vulnerable adults - Association guidelines, revised March 2016

These guidelines are for Tower Captains, Association Officers and those who teach, or help, children and vulnerable adults to ring. They're based on guidance issued by the St Albans Diocese and Central Council of Church Bell Ringers (CCCBR). Child Protection rules define a 'child' as a person under the age of 18 (or anyone who has been assessed as having a mental age of under 18). At present there isn't a definition of 'vulnerable adult'. Until we have a definition, everyone should use their own judgement.

Sunday service ringing and individual tower practices are the responsibility of that church/parish; we strongly advise all ringers to check local arrangements and comply with them.

Everyone should take safeguarding matters seriously. This will ensure that:

- Children and vulnerable adults are protected from abuse.
- Adults working with children and vulnerable adults don't put themselves in compromising situations.
- The good name of the Association, and ringing in general, is protected.

We recommend that everyone involved with children and vulnerable adults in ringing (whether they're members or not) should:

- Have a Disclosure and Barring Service (DBS) 'enhanced check' if teaching children/vulnerable adults face to face, even where supervised.
- Always have at least two adults present (preferably a male and female) when children/vulnerable adults are present at tower, District or Association practices.
- Make parents/guardians responsible for taking children/vulnerable adults to and from the church.
- Keep an attendance register or record.
- Be aware of the insurance position for children/vulnerable adults.
- Never allow children/vulnerable adults up amongst the bells apart from an initial demonstration visit if it is safe to have one.
- Get written permission from parents/guardians before children/vulnerable adults are taken without them to Tower, District and Association meetings, training, outings and social functions or other towers' practices.
- Make sure parents/guardians have agreed transport arrangements for children/vulnerable adults travelling to and from ringing, meeting, or social activities away from the home tower.
- Never travel alone in a car with a child/vulnerable adult.
- Only hold child/vulnerable adult personal contact information with the permission of parents/guardians.

If you are a Tower Captain, or someone who works with children or vulnerable adults, you should also:

- Know the child protection/safeguarding policy of your church and the 'named person' to whom you should report concerns.
- Invite parents/guardians to a training session before teaching begins so that they're fully aware of what's involved.
- Ask parents/guardians to sign a registration form which gives their permission for the child/vulnerable adult to learn to ring (downloadable from our website www.bacbr.org.uk).

The Association's Safeguarding Coordinator may contact parents/guardians to make sure they understand the Association's guidelines and their own responsibilities. For more information see the child protection notes on the CCCBR website:

Data protection

The Data Protection Act 1998 provisions came into force on the 1st March 2000. The Association is exempt from registration under the Act but must still follow the principles of good data handling.

As an Association member, a parent/guardian of a member under 18 years old or a Tower Contact who is a non-member, you should be aware that personal information (including name, address, telephone number, email address, subscription payment record and peals rung for the Association) is held and maintained electronically and on paper records for use by nominated Association Officers (including District Officers).

Association and District Officers also hold email addresses, where members give specific permission, to communicate about Association and District events and activities.

Your personal data is only used for the legitimate purposes of the Association; we do not allow personal data to be used by others. You have the right to see the data we hold about you.

By joining the Bedfordshire Association of Church Bell Ringers you agree to your name appearing in the Annual Report and, where relevant, on the Association's website, Association and District newsletter and other communications.

We do ask members and tower contacts (whether members or not), to give specific permission before other personal data, such as phone number, address and email address, is used in the Annual Report or on the Association's website.

Please help us to keep our records up to date by informing the Honorary Secretary and relevant District Secretary of any changes to your personal information.

Association and member insurance cover - reviewed 2015

The Association has an insurance policy with Ecclesiastical Insurance Group. Ringing Associations generally have public liability cover and some may also have property and/or personal injury cover. Some Associations don't provide any insurance cover at all, because they believe it is too expensive with little benefit.

We decided against providing personal insurance for every member because it is expensive and these policies may give a false sense of security as they have small pay-outs. For example, a typical pay-out is unlikely to cover your loss of earnings if you were unable to work due to a ringing accident.

We believe our cover is a good membership benefit which accounts for about £1.00 of your annual subscription. You can view our policy document on the website.

Cover includes:

- £2,000,000 public and products liability for third party claims on the Association and individual members:
- 'Member to Member' liability, if one member should sue another member;
- Property damage and unspecified risks, for our valuable assets including the striking competition trophies, President's badge and library contents.
- A very modest personal accident insurance, only for our named Technical Advisor.
- · Trustee indemnity cover

The liability cover only applies if a member isn't entitled to indemnity under any other policy and it won't apply if the member isn't complying with the terms and conditions of our policy, such as:

It is a condition of this insurance that the inspection, adjustment and repair of bells will be undertaken only by persons technically competent relating to engineering or church structures or if, in the view of such qualified persons, they are competent to perform the tasks allotted to them.

It is very difficult to give definitive advice here because 'technical competence' or 'qualified persons' aren't defined and because there are so many different circumstances.

The following may help you decide how this affects you:

- You should check the insurance position of your own church. Every church
 must have its own insurance cover. If you're teaching learners in your own
 tower then you're likely to be covered by your church policy, but upper and
 lower age limits may apply. If you are teaching outside your own tower then
 you'll need to check your insurance position at that tower.
- If you are doing more than 'routine maintenance' then you may not be covered by your church policy. You should seek specific advice for any work that could be considered as more than routine maintenance.
- If you are a volunteer worker for any bell or tower work project being carried out by recognised, professional bell engineers, you may be able to get some cover under their policy but check beforehand, is it for liability or accidents?
- Members of the Association of Ringing Teachers (ART) should check how they are covered through ART's insurance policy for teaching at towers within and outside the Association's area.
